Sir.

National Cooperative Development Corporation (NCDC), a Statutory Corporation under the Ministry of Cooperation, Govt. of India requires the services of suitable officers for appointment against vacant posts of Deputy Director in the Corporation on deputation basis on foreign service terms. The details of age, educational qualification, experience and other eligibility criteria of appointment on deputation basis for the post of Deputy Director are given at Annexure I. The appointment would be on the usual terms and conditions of deputation as applicable to employees of Central/ State Governments/ Autonomous organizations working on deputation with statutory bodies. The period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department or the Central Government shall ordinarily not to exceed 4 (four) years. The maximum age limit for appointment by transfer on deputation (including short-term contract)/transfer shall be, 56 years, as on the closing date of receipt of applications.

- 2. Applications of only such officers will be considered which are routed through proper channel and are accompanied by (i) bio-data (in duplicate) as in the proforma given in <u>Annexure-II</u>, (ii) Duly attested photocopies of ACRs for the last five years, (iii) vigilance clearance/integrity Certificate (Annexure-III), and (iv) statement giving details of major or minor penalties imposed on the officer, if any, during the past ten years.
- 3.
